**Sub: 46<sup>th</sup> IPS Induction Training Course from September 2<sup>nd</sup>, 2024 to October 11<sup>th</sup>, 2024 – Inviting nominations regarding.**

Madam/Sir,

A 6-week 'IPS Induction Training Course' (ITC-46<sup>th</sup>) is scheduled to be held at the Academy from **September 2<sup>nd</sup>, 2024 to October 11<sup>th</sup>, 2024**. The Course is meant for the State Police Service (SPS) Officers inducted into the Indian Police Service (IPS) and who have not attended the Induction Training Course at this Academy in the past.

2. As per the Ministry of Home Affairs, Government of India Fax Message No.1-18012/3/2002-IPS dated 17.04.2002, completion of IPS Induction Training Course at Sardar Vallabhbhai Patel National Police Academy, Hyderabad is a compulsory pre-condition for confirmation of State Police Service Officers in the IPS.
3. The objectives of the course are to enable the participants:
  - (i) To acquire an all-India perspective,
  - (ii) To equip them with knowledge and skills required to manage a district charge, and
  - (iii) To enable them to develop an understanding of modern management principles as applied to police working.
4. The nominations for the course may please be sent to the Academy latest by **01<sup>st</sup> August, 2024** through fax No. 040-24015179 and on e-mail id [mctp@svpnpa.gov.in](mailto:mctp@svpnpa.gov.in) for acceptance and forwarding joining instructions to the nominated officers directly. **For any assistance, SI(Trg) Ch. Srinivas, I/c MCTP Section can be contacted on landline No. 040-24234751, Mobile No. 8309949187.**

5. **Eligibility** : IPS officers inducted from State Police Service (SPS) (including those working on deputation in CPOs and **who have not attended the 'Induction Training Course' or Mid-Career Training Programme Phase-III at this Academy in the past** are eligible for the 46<sup>th</sup> ITC. It may also be noted that **officers who have less than 4 years of service, left at the time of his/her induction into IPS are not eligible for the 46<sup>th</sup> ITC.**

6. **Nominations** : It is requested to nominate eligible State Police Service (SPS) officers inducted into IPS, of the rank of SP & above to attend the proposed Induction Training Course. **There is no bar on total number of nominations from any State / Cadre.** Final acceptance of nominations will be done by the Academy and confirmation of acceptance of nominations will be conveyed to respective State/UTs/CAPFs/CPOs. It is requested to ensure that nominated officers are medically fit to undergo the entire course.

7. Nominations for 46<sup>th</sup> ITC may be sent in the format enclosed as Annexure 'A' along with a copy of MHA order (induction into IPS) & a copy of the undertaking certificate from the concerned officer that he has not attend either ITC of MCTP Phase-III in the past at this Academy. States where government permissions is required to send nominations, it is requested to send an advance copy to SVP National Police Academy, Hyderabad to complete required formalities, well in advance. However, the **nominations will be accepted subject to the clearance/No objection from the concerned Government of State / UT.** In such cases, the participants are to be sent for attending the subject course only on receipt of the clearance/no objection from the concerned.

8. Only those officers who have no disciplinary/criminal proceedings pending against them may be nominated for the course and the States/Organizations are requested to certify to this effect while forwarding their nominations.

9. Detailed joining instructions will be issued to the participants, once the nominations are accepted by this Academy.

10. **The nominated officers may please be advised to proceed for the course only after receiving confirmation of acceptance of their nominations from the Academy.**
