NOTIFICATION

This Ministry's vide Notification No. I-15016/6/2016-IPS.I dated 18.10.2018 "Provisionally" included Smt Violet Baruah (Date of Birth: 25.07.1962) at Sl No.0A above the name of Sh Debojit Hazarika (Sl. No. 01) in the Select List of **2009-A** and at Sl No.0A 'provisionally' above the name of Shri Mridual Kumar Dutta (Sl No. 01) in the Select list **2010** for promotion to the IPS of Assam segment of Joint A&M Cadre provisionally subject to clearance in the disciplinary proceedings pending against her and grant of Integrity Certificate by the State Government.

- 2. Now Government of Assam vide letter dated 21.12.2018 have forwarded the proposal before the Union Public Service Commission (UPSC) for unconditional inclusion of Smt Violet Baruah for promotion to the IPS for the Select List- 2009-A and 2010, as the disciplinary proceedings against Smt Violet Baruah has been dropped vide order No. HMA.652/2016/177 dated 12.12.2018.
- 3. The matter was placed before the Commission. The Commission has decided to declare inclusion the name of Smt Violet Baruah at Sl No. 0A for the Select List-2009-A prepared by the Review Selection Committee Meeting met on 17.05.2018 to consider the name of Smt Violet Baruah for the Select List-2009A & 2010 in compliance with the order dated 13.02.2017 passed by the Hon'ble Gahuati High Court in WP(C) 3021/1015 filed by Smt Violet Baruah Vs UOI and others as "unconditional and final".
- 4. Consequent upon inclusion of the name of Smt Violet Baruah at S.No 0A above the name of Shri Shri Debojit Hazarika (Sl. No. 01) in the Select List 2009A and the approval of the Union Public Service Commission on 28.12.2018 to the recommendations of the Review Selection Committee which met on 17.05.2018 to reconsider the name of Smt Violet Baruah for inclusion in the Select List of 2009-A for appointment by promotion to Assam Segment of Joint A&M Cadre of IPS in compliance of order dated 13.02.2017 of the Hon'ble Gauhati High Court in WP (C) 3021/1015 filed by Smt Violet Baruah Vs UOI and others and in exercise of the powers conferred by sub-rule (1) of rule 9 of the Indian Police Service (Recruitment) Rules, 1954, read with sub-regulation (1) of regulations 9 of the Indian Police Service (Appointment by Promotion) Regulations, 1955, and to appoint Smt Violet Baruah (Date of Birth: 25.07.1962) (officer earlier appointed from the Select List of 2011) to the Assam Segment of Joint A&M cadre of Indian Police Service against the Select List 2009-A.
