// ORDER//

Consequent upon appointment of 20 officers of Uttar Pradesh Police Service to the Indian Police Service of Uttar Pradesh cadre, on the basis of inclusion of their names for Select List 2024 vide MHA's Notification No. I-14011/23/2025-IPS-I(II) dated 13.08.2025 and on receipt of the proposal from Government of Uttar Pradesh, vide their letter No. 1222डीजी/छ:प0से0-2-2025 dated 21.11.2025, the seniority/year of allotment of the officers is computed under Rule 3 (3) (ii) of the IPS (Regulation of Seniority), Rules 1988, as amended from time to time and other relevant rules. No. 1 to 5** shall be placed below **Shri Mayaram (IPS: 2017)**, the junior most promote IPS officer of 2017 batch of the Uttar Pradesh Cadre and above **Shri Saad Miya Khan (IPS: 2018)**, the senior most direct recruit IPS officer of 2018 batch of Uttar Pradesh Cadre.



(ii) Officers mentioned from **Sl. No. 6 to 20** shall be placed below **Shri Aniruddh Kumar (IPS: 2018)**, the junior most direct recruit IPS officer of 2018 batch of the Uttar Pradesh Cadre and above **Shri Abhinav Tyagi (IPS: 2019)**, the senior most direct recruit IPS officer of 2019 batch of Uttar Pradesh Cadre.
