Government, he has willfully neglected his probationary studies or duties or is guilty of conduct unbecoming of a member of the Service, may be treated under Rule- 11 (3) and 12 (c) & (d) of the IPS (Probation) Rules, 1954. In this regard, it is intimated that the officer, who will not attend the Foundation Course after his name is nominated for the course, disciplinary action may be initiated under Rule-11 (3) and 12 (c) & (d) of the Indian Police Service (Probation) Rules, 1954.

- 5. State Governments are requested for relieving such Direct Recruit IPS Probationers for the said course well in time as the course is to commence in 2019. The Schedule/programme of the 94th Foundation Course, update if any, will be intimated as and when the same is received from DoP&T.
