- 2. I am directed to invite your kind attention on the subject cited above and to submit that Dr. Akhil Chaudhary, IPS (PB:2012) Assistant Inspector General of Police, Personnel-II, Punjab, Chandigarh in his request dated 8.8.2024, had given specific willingness for central deputation in Central Bureau of Investigation (CBI) only based on his interest/inclination/aptitude for investigation work and vacancies at SP level. Neither, he had given any general willingness nor this office had recommended his name for central deputation to be considered in "Offer list". The State Government had also not recommended to MHA for considering the name of the said officer in "Offer list".
- 3. However, MHA vide letter No. I-21015/33/2024-IPS.III dated 4.10.2024 has conveyed the approval of competent authority appointing the said officer as Superintendent of Police in Bureau of Police Research & Development (BPR&D).
- 4. Dr. Akhil Chaudhary is disinclined to join BPR&D on central deputation basis.
- 5. In view of the position explained above, it is requested that Dr. Akhil Chaudhary, IPS may not be debarred from central deputation and foreign assignments / consultancies."
