Sir,

I am directed to invite your attention on this Ministry's letter No. 26011/47/2010-IPS.II (Vol.II) dated 20th September, 2011 (copy enclosed) on the subject cited above and to say that the Central Vigilance Commission has revised the existing proforma for seeking vigilance status of IPS officers for consideration for empanelment to various levels at the Centre.

2. While forwarding vigilance profile of IPS officers for seeking comments of the CVC on the vigilance status of IPS officers for empanelment to various level posts, no information regarding complaints pending, if any, is presently furnished. Complaints, either with the Centre or the State, taken up for verification/inquiry/investigation which are pending and yet to be disposed of are not reflected in the vigilance history. Therefore, Central Vigilance Commission (CVC) has now revised the existing proforma on vigilance profile and desired to furnish the information regarding pending complaints (both with Centre and State) so that the Commission can take a considered view on the vigilance status of the officer.

It is requested that the details in respect of each IPS officers in the revised prescribed format (copy enclosed) be forwarded to this Ministry as and when vigilance status of a particular batch/batches of IPS officers are considered for empanelment to reviewed for empanelment with reference to DoP&T instruction issued vide O.M. No.104/33/2005-AVD.I dated 29.10.2007 (copy can be downloaded from the DoP&T website).


