

Sub: Representation of Shri Gajbhiye S.K. Ishwardas, IPS(OD-2002) regarding Central Deputation.


Sir,

Thereafter, Government of India, MHA vide their letter dated 06.12.2024(copy enclosed) had conveyed the approval of the competent authority for appointment of Shri Gajbhiye S.K. Ishwardas, IPS as Deputy Inspector General(DIG) in Central Reserve Police Force(CRPF). Accordingly Shri Gajbhiye has been placed at the disposal of the Government of India, MHA for central deputation vide Home Department Notification 12.12.2024 (copy enclosed ).
