I am directed to refer to Government of Gujarat's letters No. IPS/102022/GoI-68/B dated 13.01.2023 and No.IPS/102022/GoI-243/B dated 13.01.2023 on the subject cited and to say that the authorized promotion quota of Gujarat Cadre of IPS as on 01.01.2022 was 63, whereas 57 officers were in position as on the due date. Out of 06 vacancies, 01 vacancy is carried forward from Select List 2020 & remaining 05 vacancies have occurred due to retirement of 05 promotee IPS Officers in the year 2021.

2. Therefore, in terms of the provisions contained in Rule 4 (2) of the IPS Recruitment Rules, 1954 read with Regulation 5(1) of IPS (Appointment by Promotion) Regulations, 1955, **06** vacancies are determined for the Select List of the year **2021** for appointment by promotion of Gujarat Police Service officers to the Gujarat Cadre of Indian Police Service.

3. Further, the authorized promotion quota of Gujarat Cadre of IPS as on 01.01.2023 is 63, whereas 55 officers were in position as on the due date and thus making 08 vacancies in total. Out of these 08 vacancies, 06 vacancies is being determined for the Select List year 2021 (para 2 above) and remaining 02 vacancies are due to retirement of 02 officers during year 2022.

4. Therefore, in terms of the provisions contained in Rule 4 (2) of the IPS Recruitment Rules, 1954 read with Regulation 5(1) of IPS (Appointment by Promotion) Regulations, 1955, **02** vacancies are determined for the Select List of the year **2022** for appointment by promotion of Gujarat Police Service officers to the Gujarat Cadre of Indian Police Service.
