- 2. It was indicated in para 1 (c) of the OM that during their tenure as Under Secretary/ Deputy Secretary/ Director, the officers will be paid CDTA at the rate of 10% of their basic pay, subject to a ceiling of Rs. 9000;
- 3. In consideration of references received from various Ministries/Departments and after due consultation with Department of Expenditure it has been decided that the ceiling will further rise by 25 percent each time Dearness Allowance increases by 50 percent.
- This issues with the concurrence of the Department of Expenditure conveyed vide their ID note no. 9/6/2024-E. II (B) dated 29.04.2025. All others terms and conditions regulating the CDTA, as contained in this Department's OM No. 2/10/2017-Estt. (Pay-II) dated 24.04.2018 remain unchanged.
