- 4. As per the Indian Police Service (Probation) Rules, 1954, if a probationer fails to obey any order which he/she may receive from the Central Government or from any other competent authority, or if in the opinion of the Central Government, he has willfully neglected his probationary studies or duties or is guilty of conduct unbecoming of a member of the Service, he/she may be treated under Rule- 11 (3) and 12 (c) & (d) of the IPS (Probation) Rules, 1954. In this regard, it is intimated that the officer, who do not attend the Foundation Course after his name is nominated for the course, disciplinary action may be initiated under Rule-11 (3) and 12 (c) & (d) of the Indian Police Service (Probation) Rules, 1954.
- 5. State Governments are requested to relieve the concerned Direct Recruit backlog IPS Probationers mentioned in **Annexure-I** for the said course well in time as the course scheduled to commence at Dr, MCRHRD Hyderabad w.e.f. 03.02.2020.
