Sub: - Fixation of pay of IPS officers on Central Deputation to CPOs/CAPFs/Attached Offices under Ministry of Home Affairs and other Organizations/Ministry /Departments – Reg.

.

The undersigned is directed to refer to IPS (Pay) Rules, 2016 and to say that this Ministry has received many requests from CPOs/CAPFs/Attached Offices under Ministry of Home Affairs and other Organizations/Ministry/Departments regarding pay fixation of IPS officers on implementation of 7th CPC.

2. The matter was considered by this Ministry in consultation with DoP&T and it has been decided that pay fixation of IPS officers on Central Deputation to CPOs/CAPFs/Attached Offices under MHA/ other Organizations/Ministry/Departments on implementation of 7th C.P.C w.e.f 01.01.2016 will be fixed by seeking Notional/Presumptive pay in respective parent cadre as on 01.01.2016 as per 7th CPC from respective State Government by the concerned organization/Department and then the pay of officer will be fixed on central deputation at the cell which is equal to or less than the Notional/Presumptive pay in cadre at the level of respective post in Pay Matrix on central deputation.

3. Further, it is clarified that on grant of proforma promotion in parent cadre, Notional/Presumptive pay in respective parent cadre would be sought from respective State Government by the concerned organization/Department and then the pay of officer will be fixed on central deputation at the cell which is equal to or less than the Notional/Presumptive pay in cadre at the level of respective post in Pay Matrix on central deputation.

4. It is further stated that 7th CPC Cell, Department of Expenditure has also been requested by DoP&T to issue necessary clarification on fixation of pay. In case of variation in the method so adopted, the same will be communicated. Overpayment if any, either in the form of arrears or otherwise shall be recovered from the officer concerned.

5. In view of the above, it is requested that the pay fixation of IPS officers on central deputation as on 01.01.2016 may be done by respective organization/Department without the concurrence of this Ministry as per Para 2 above. Further the pay fixation proposal on appointment/ proforma promotion in parent cadre may be sent to this Ministry for concurrence as per Para 3 above in a Single File System.
