Sub.: Nomination of IPS officers upto 2016 Batch for 93<sup>rd</sup> Foundation Course to be conducted by LBSNAA, Mussoorie - Regarding.
Sir.

I am directed to refer to the subject and to say that DoP&T is in the process of organizing 93<sup>rd</sup> Foundation Course in respect of Direct Recruit AIS and other Central Govt. 'A' services backlog officers, which is likely to be conducted by the LBS National Academy of Administration, Mussoorie from 27.08.2018 to 07.12.2018.

- 2. In this regard, it is informed that as per records available with this Ministry total 102 Direct Recruit IPS officers upto 2016 Batch have not undergone Foundation Course so far. The list of these Officers are at Annexure-I. The list of IPS officers, who have also not undergone Foundation Course but either resigned from IPS or has been discharged from IPS is also enclosed at Annexure-II.
- 3. State Governments are requested to ensure that no Direct Recruit IPS officer upto the 2016 Batch should remain left out for nomination from attending the 93<sup>rd</sup> Foundation Course. If there is any such officer who has not so far undergone the mandatory Foundation Course, but his name is not included in the Annexure-I, the same may be intimated to this Ministry immediately through mail ID soips4@mha.gov.in so as to enable us to forward his/her name to DoP&T for attending 93<sup>rd</sup> Foundation Course.

- 4. As per the Indian Police Service (Probation) Rules, 1954, if a probationer fails to obey any order which he/she may receive from the Central Government or from any other competent authority, or if in the opinion of the Central Government, he has willfully neglected his probationary studies or duties or is guilty of conduct unbecoming of a member of the Service, may be treated under Rule- 11 (3) and 12 (c) & (d) of the IPS (Probation) Rules, 1954. In this regard, it is intimated that the officer, who will not willfully attend the Foundation Course after his name is nominated for the course, disciplinary action may be initiated under Rule-11 (c) and 12 (c) & (d) of the Indian Police Service (Probation) Rules, 1954.
- 5. State Governments are requested to remain prepared for relieving such Direct Recruit IPS officers for the said course well in time. The Schedule/programme of the 93<sup>rd</sup> Foundation Course, update if any, will be intimated as and when the same is received from DoP&T.
- 6. This may please be accorded TOP PRIORITY.
