Sub: Appointment of Shri Rajeev Mishra, IPS (WB:96), on deputation basis in Central Government-reg.

Sir,

I am directed to refer to this Ministry's letter of even number dated 11.12.2020 seeking concurrence of the Govt. of West Bengal for considering appointment of Shri Rajeev Mishra, IPS (WB:96) on central deputation basis and Govt. of West Bengal letter No. 188/US dated 11.12.2020 conveying their objection in the matter.


2. Further, attention is invited towards the Rule 6(1) of IPS (cadre) Rules 1954, which stipulates:

A cadre officer may, with the concurrence of the State Government or the State Governments concerned and the Central Government, be deputed for service under the Central Government or another State Government or under a company, association or body of individuals, whether incorporated or not which is wholly or substantially owned or controlled by the Central Government or by another State Government.

Provided that in case of any disagreement, the matter shall be decided by the Central Government and the State Government or State Governments concerned shall give effect to the decision of the Central Government.

3. The reply furnished by the State Government has been examined in the light of the aforesaid rule as referred in para 2 above and considering the public interest, proviso to Rule 6(1) of the IPS (Cadre Rules), 1954, is hereby invoked and the competent authority has accordingly approved the appointment of Shri Rajeev Mishra, IPS (WB:96) in Central Government, on deputation basis. He is appointed to the post of Inspector General (Level-14 in the Pay Matrix) in ITBP, against the existing vacancy, for a period of five years from the date of assumption of charge of the post by the officer or till further orders, whichever is earlier.

4. Therefore, the State Government is requested to relieve the officer immediately to enable him to join his new assignment at the centre.
