Subject: Special Foundation Course for the backlog candidates - reg.

Sir,

I am directed to refer to the subject cited above and to say that as intimated by the DoP&T a Special Foundation Course, other than Common Foundation Course is to be conducted for backlog officers upto 2017 batch.

2. In this regard, it is informed that as per records available with this Ministry a total of 23 Direct Recruit IPS backlog officers upto 71 RR, have not undergone Foundation Course so far. The list of those Officers is enclosed at **Annexure-I**.

3. In addition to above there are 30 IPS backlog officers (Probationers) of 2018 batch who have completed their Basic Course Training. The Ministry of Home Affairs have also recommended to DoP&T to nominate those officers in upcoming Special Foundation Course. The list of 30 IPS officers is enclosed at **Annexure-II**.

4. State Governments are requested to ensure that no Direct Recruit IPS Probationer upto 2017 batch should be left out for nomination from attending the Special Foundation Course. If there is any Direct Recruit IPS officer who has not so far undergone the mandatory Foundation Course but his name is not included in the Annexure-I, the same may be intimated to this Ministry immediately through email ID soips4@mha.gov.in so as to enable us to forward his/her name to DoP&T for attending Special Foundation Course.

5. As per the Indian Police Service (Probation) Rules, 1954, if a probationer fails to obey any order which he/she may receive from the Central Government or from any other competent authority, or if in the opinion of the Central Government, he has willfully neglected his probationary studies or duties or is guilty of conduct unbecoming of a member of the Service, he/she may be treated under Rule-11 (3) and 12 (c) & (d) of the IPS (Probation) Rules, 1954. In this regard, it is intimated that the officer, who do not attend the Foundation Course after his name is nominated for the course, disciplinary action may be initiated under Rule-11 (3) and 12 (c) & (d) of the Indian Police Service (Probation) Rules, 1954.

6. State Governments are requested to get prepared for relieving such Direct Recruit IPS backlog officers upto 2018 batch for the said course and relieve them well in time as and when schedule/venue of the course is received from DoP&T.


