Government of Karnataka vide their letter number DPAR.10.SPS.2019 dated 18.06.2020, has sent a proposal for fixation of seniority/year of allotment of IPS officers, appointed on promotion from SPS quota, on the basis of inclusion of their names in the Select Lists of the year 2014 & 2015 of Karnataka Cadre. These officers have been appointed IPS vide GOI Notification No. I-14011/21/2016.IPS. I(II) dated 31.03.2017 and I-14011/24/2017.IPS. I(II) dated 21.07.2017, 10.01.2018 & 01.11.2017.

2. The Seniority/year of allotment of officers of the Select List 2014 & 2015 has been computed as per Rule 3 (3)(ii) of the IPS Regulation of Seniority Rules, 1988 and as per amended seniority rules issued by DOP&T vide their notification dated 18.04.2012. 4. As per Rule 4 of the IPS (Regulation of Seniority) Rules, 1988, the placement of above officers in the Civil List will be as under:-

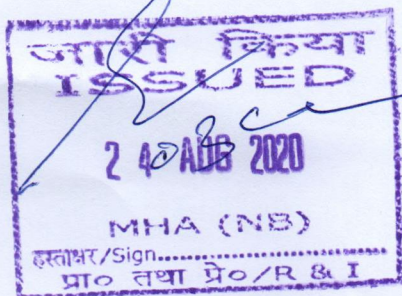
