// ORDER //

Government of Jharkhand vide their letter number 13/P2-101/2017 dated 30.04.2020, has sent a proposal for fixation of seniority/year of allotment of IPS officers appointed on promotion from SPS quota on the basis of inclusion of their names in the Select Lists of the year 2015. These officers have been appointed to IPS vide GOI Notification No. I-14011/11/2016.IPS. I(II) dated 25.04.2017.

2. The Seniority/year of allotment of officers of the Select List - 2015 have been computed as per Rule 3 (3)(ii) of the IPS Regulation of Seniority Rules, 1988 and as per amended seniority rules issued by DOP&T vide their notification dated 18.04.2012.
