## // **ORDER** //

Whereas, Ministry of Personnel, Public Grievances and Pensions, DOP&T vide O.M. No. 14014/14/2014-AIS-I dated 21.08.2017 intimated that in the wake of Hon'ble High Court of Punjab and Haryana order dated 01.02.2010 in CWP No. 15798/2009 in the case of Praveen Kumar, a State Civil Service officer of Punjab cadre Vs Union of India as confirmed by Hon'ble Supreme Court, issued notification dated 18.04.2012 for making amendment in the respective seniority regulations for IAS/IPS/IFoS. These amendments were however made applicable to the Select Lists prepared as per the ratio laid down in the case of Praveen Kumar and accordingly, seniority/year of allotment of the officers included in the said Select Lists were determined as per the amended seniority regulations.

- 2. Whereas, consequent upon dismissal of SLP No. 4930-4931 of 2016 and Review Petition No. 001428-001429/2017 filed by the DoP&T in case of F R Jamadar and other connected court cases filed by this Ministry, it was decided to apply the amended seniority regulations prospectively i.e. wef 18.04.2012. Accordingly, Seniority/year of allotment of the IPS officers appointed during 01.02.2010 to 18.04.2012 from the Select Lists prepared as per ratio laid down in the Praveen Kumar case was decided to be re-determined as per the pre-amended seniority Regulations.
- 3. Whereas, the DOP&T vide OM No. 14014/14/2014-AIS-I dated 03.11.2017 decided that seniority/ year of allotment of officer appointed after 18.04.2012 against the vacancies arisen between 1.2.2010 to 18.04.2012 be fixed as per pre-amended seniority rules throughout the cadres.
- 4. Whereas, DOP&T OM No. 14014/14/2014-AIS –I dated 22.01.2018 also decided to count the service of the officer rendered in the rank of Deputy SP or equivalent upto the 31<sup>st</sup> December of the vacancy year against which he was appointed to the IPS. The matter regarding fixation of seniority as per DOP&T O. M. dated 21.08.2017, 03.11.2017 and 22.01.2018 was duly examined and the competent authority decided to implement the said decisions conveyed by DOP&T, vide this Ministry's order No. 15011 /07/2012-IPS-I (Part) dated 21.03.2018.
- 5. Whereas, Shri R.A. Sanjeev and others had filed O.A. No. 2982/2012 in CAT, Principal Bench, Delhi. The Hon'ble Tribunal passed order dated 29.05.2015 in favour of Shri R.A.Sanjeev and others which was upheld by Hon'ble High Court of Delhi and the SLP No. 33064/2016 filed by this Ministry was also dismissed by the Hon'ble Supreme Court on 01.08.2017. As such, the Order dated 29.05.2015 of the CAT, Principal Bench attained finality.
- 6. And whereas, the issue regarding Approved Service was also examined in consultation with UT Division in their File No. 14016/01/2017-UTS-I wherein the competent authority decided to re-determine the seniority of UT Segment of the Joint AGMUT Cadre of IPS in compliance of the aforesaid order of the CAT, Principal Bench, New Delhi in OA No. 2982/2012.
- 7. Accordingly, in modification of this Ministry's order No. 15011/07/2012-IPS-I (Part) dated 21.03.2018 & No. I.15011/7/2012-IPS-I dated 23.04.2018 the seniority/year of allotment of the officers appointed by promotion to UT Segment of AGMUT Cadre of IPS from the Select Lists 2007-A, 2008, 2010 and 2011 is hereby re-determined as follows:-

- the year of allotment in respect of the officers at Sl No. 1,2, 9, 10, 33 & 34 has been restricted in pursuance to first proviso to Rule 3 (3) (ii) of IPS (Regulation of Seniority) Rules, 1988.
- 8. As per Rule 4 of the IPS (Regulation of Seniority) Rules, 1988, the placement of above officers in the Select List will be as under as per Civil List- 2017:-
  - The officers from Sl No. 4 to 7 shall be placed en bloc below Ms Sindhu Pillai A, (RR: 2001), the junior most direct recruit IPS officer of 2001 batch to the AGMUT Cadre of IPS and above Shri Sanjay Kumar Jain (RR: 2002), the senior direct recruit IPS officer of 2002 batch of AGMUT Cadre of IPS.
  - The officers from Sl No. 8,9,12,15,16,& 17 shall be placed en bloc below Shri John Neihalia (SPS: 2002), the SPS IPS officer of 2002 batch to the AGMUT Cadre of IPS and above Shri Sang Norbu Mossobi (SPS: 2003), the senior SPS IPS officer of 2003 batch of AGMUT Cadre of IPS.
