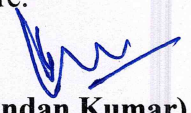

No. 7 to 8** shall be placed in same order below **Shri Pankaj Kumar Meena (IPS: 2020)**, the junior most direct recruit IPS officer of 2020 batch of the Andhra Pradesh Cadre and above **Shri Navjyoti Mishra (IPS: 2021)**, the senior most direct recruit IPS officer of 2021 batch of Andhra Pradesh Cadre.
