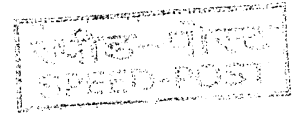

// ORDER //

Whereas, the State Government vide letter dated GAD01-PersoIPS/12/2018-SCC dated 19.06.2018 has forwarded the representation dated 09.05.2018 of Shri G Srinivas requesting for modification of his year of allotment as 2002 instead of 2003.

2. And Whereas, the Selection Committee Meeting to prepare the year wise Select Lists of 2008 and 2009 was convened on 09.11.2009 while the minutes of the meeting were approved by the UPSC on 09.03.2010 i.e. after 01.02.2010, the date from which judgment in Praveen Kumar's case was made effective vide DOPT OM dated 25.08.2010.

3. And Whereas, DoPT OM dated 25.08.2010 issued in the wake of Punjab and High Court order dated 01.02.2010 in Civil WP No. 15798 of 2009 filed by Shri Praveen Kumar s UPSC and others as confirmed by the Hon'ble Supreme Court in SLP No. 14002 of 2002 – UOI Vs Praveen Kumar stipulates that wherever meetings of the selection committee in respect of any AIS have not been held or have been held but minutes of the meeting have not been approved by the Commission, the same will be held in accordance with the interpretation of regulations given by the High Court and confirmed by the Hon'ble Supreme Court.

4. And Whereas, in the case of Shri J Satyanarayan and Shri J Prabhakar Rao appointed to IPS from the Select List 2008 (prepared against vacancies of 2007) MHA had already styled the Select List as 2007A as per Praveen Kumar's case and re fixed seniority accordingly vide order dated 12.08.2015 in compliance of the CAT Hyderabad Bench order dated 04.08.2014 in OA No. 84/2011 filed by the applicant subject to outcome of W.P. No. 9995/2016 filed by this Ministry against the order dated 12.08.2015 of CAT, Hyderabad.

5. And whereas, the representation has been examined in consultation with DOP&T for modification of the year of screening committee meeting for select list year 2008A instead of 2009 duly changing his year of allotment from 2003 to 2002 in similar lines as was done in case of Shri J Satyanarayan, IPS and Shri J Prabhakar Rao, whose year of allotment modified from 2003 to 2002 by this Ministry order dated 12.08.2015 and also year of allotment modified in case of IPS officer appointed by promotion for the Select List years 2009A and 2010 by this Ministry dated 14.03.2018.

6. And whereas, it has now been decided that it will be logical to restyle the Select List 2008, 2009 in terms of Praveen Kumar Judgment and re-fixed seniority of the officer as per pre-amended seniority Regulations.

7. And whereas, Seniority of officers appointed from the Select List 2008 has already been revised in terms of Praveen Kumar's judgment and seniority/year of allotment of the officers has been fixed vide order no. I-14013/32/2015-IPS.I dated 12 August, 2015, subject to outcome of the Writ Petition No. 9995/2016 filed by the Ministry of Home Affairs against order dated 04.08.2014 of the Hon'ble CAT Hyderabad bench. It is also mentioned that 4 officers were appointed for the Select List- 2009, out of which two officers are in Andhra Pradesh Cadre and another two are in Telangana Cadre. Accordingly the seniority/year of allotment of the officers appointed by promotion to IPS of Andhra Pradesh Cadre from the Select List 2009 is being revised in terms of pre-amended seniority rules as follows in supercession /modification of this Ministry's order No. 15011/9/2010-IPS-I date 08.07.2010.

8. And Therefore, the seniority/year of allotment of the officers appointed to IPS by Select List 2008-A (Prepared against the vacancies arisen between 01.01.2008 to 31.12.2008) has been re-determined as per pre-amended Seniority Regulations as under as per following weightage formula :-

10. As per Rule 4 of the IPS (Regulation of Seniority) Rules, 1988, the placement of above officers as per Civil List- 2018 will be as under:-

(i) **Shri G Srinivas and D Nagendra Kumar**, shall be placed enblock below of **Shri J Prabhakar Rao, (SPS: 2002)**, the junior most SPS IPS officer of 2002 batch to the Andhra Pradesh Cadre of IPS and above **Shri Kanthi Rana Tata (RR: 2004)**, the senior most direct recruit IPS officer of 2004 batch of Andhra Pradesh Cadre.

(ii) **Shri A Satyanarayana and Dr V Ravinder**, shall be placed below of **Shri N Shiva Shankar Reddy, (SPS: 2002)**, the junior most SPS IPS officer of 2002 batch to the Telangana Cadre of IPS and above **Shri Shahanawaz Qasim (RR: 2003)**, the only senior most direct recruit IPS officer of 2003 batch of Telangana Cadre.

11. However, the above modification in year of allotment in respect of Srl No. 1 to 4 shall be subject to the outcome of the Writ Petition No. 9995/2016 filed by the Ministry against order dated 04.08.2014 of the Hon'ble CAT, Hyderabad Bench in the case of Shri J Satyanarayan, IPS and Shri J Prabhakar Rao.
