// ORDER //

Government of Assam, vide letter No. HMA. 14/2020/20 dated 14-01-2020, has sent a proposal for fixation of seniority of IPS officers appointed on promotion from SPS quota of **Assam Segment of Joint Assam-Meghalaya Cadre** on the basis of inclusion of their names in the Select Lists of the year 2012 to 2017 for fixation of seniority / year of allotment.

2. The seniority/year of allotment of the officers of the Select Lists of the year 2012 to 2017 has been computed under Rule 3 (3) (ii) of the IPS (Regulation of Seniority), Rules 1988, amended as per DOP&T vide notification No. 14014/4/2011-AIS-I(B) dated 18.04.2012 and other relevant rules. Modified weightage formula is now as under:-





P. Ghanawat (RR: 2010)**, the senior most direct recruit IPS officer of 2010 batch of Joint Assam-Meghalaya Cadre.

No. 8 shall be placed enblock below **Shri Rajveer (RR: 2010)**, the junior most direct recruit IPS officer of 2010 batch of Joint Assam-Meghalaya Cadre of IPS and **above Shri Mohneesh Mishra (RR: 2011)**, the senior most direct recruit IPS officer of 2011 batch of Joint Assam-Meghalaya Cadre.
