// ORDER //

The State Government of Bihar vide their letter No. 01/C01-08/2019/4574 dated 01.07.2020 has sent a proposal for fixation of seniority of IPS officers appointed on promotion from SPS quota on the basis of inclusion of their names in the Select Lists of the year 2016 & 2017. These officers have been appointed to IPS vide GOI Notification No. I-14011/10/2018-IPS.I (II) dated 26.12.2018.

2. The Seniority/year of allotment of officers of the Select List 2016 & 2017 has been computed as per Rule 3 (3)(ii) of the IPS Regulation of Seniority Rules, 1988 and as per amended seniority rules issued by DOP&T vide their notification dated 18.04.2012. The Weightage formula as per amended seniority rules are as under:-



4. As per Rule 4 of the IPS (Regulation of Seniority) Rules, 1988, the placement of above officers in the Civil List will be as under:-


