// ORDER //

The Government of Bihar vide their letter No.-1/C01-08/2019GR-5534 dated 04.05.2023 has sent a proposal for fixation of seniority of 10 IPS officers appointed on promotion from SPS quota of Bihar Cadre on the basis of inclusion of their names in the Select List of the year 2017 to 2021.

2. The seniority/year of allotment of these officers has been computed under Rule 3(3)(ii) of the IPS (Regulation of Seniority), Rules 1988, as amended vide notification No. 14014/4/2011-AIS-I(B) dated 18.04.2012 and other relevant rules. Modified weightage formula is now as under:-






