// ORDER //

The Government of Haryana's vide letter No. 4/3/2015-2HG-I dated 01.03.2018 dated 07.06.2017 and dated 29.08.2019 has sent a proposal for fixation of seniority of IPS officers appointed on promotion from SPS quota on the basis of inclusion of their names in the Select Lists of the year 2012, 2013, 2014 & 2015 for fixation of seniority/year of allotment. These officers have been appointed to IPS vide GOI Notification No. I.14011/12/2016.IPS. I(II) dated 28th February, 2017 and 16.11.2017.

2. The fixation of seniority of the Select Lists of the year 2012, 2013, 2014 & 2015 have been computed Rule 3 (3)(ii) of the IPS Regulation of Seniority Rules, 1988 as per pre-amended seniority rules as per DOP&T vide their notification dated 18.04.2012.
