State Govt. of Chhattisgarh, vide letter no. F-01-22/2006/2-Home/IPS dated 10.08.2021, has sent a proposal for seniority fixation of eligible IPS officers appointed on promotion from SPS quota on the basis of inclusion of their names in Select List of year 2017.

2. The Seniority/year of allotment of officers has been computed as per Rule 3 (3)(ii) of the IPS Regulation of Seniority Rules, 1988 and as per amended seniority rules issued by DOP&T vide their notification dated 18.04.2012. Weightage formulas as per **amended seniority rules** are as under:-

- Officer mentioned in Sl. No. 5 to 10 shall be placed enblock below Shri Ashutosh Singh (RR: 2012), the direct recruit IPS officer of 2012 batch of the Chhattisgarh Cadre and above Shri Jitendra Shukla (RR: 2013), the senior most direct recruit IPS officer of 2013 batch of Chhattisgarh Cadre.
