State Govt. of Chhattisgarh, vide letter no. F-1-09/2017/2-Home/IPS dated 14.06.2024, has sent a proposal for seniority fixation of Shri Rajnesh Singh, IPS who was appointed to IPS by way of promotion from SPS quota on the basis of inclusion of his name in Select List of 2017.
