State Govt. of Chhattisgarh, vide letter no. F-01-22/2006/2-Home/IPS(part) dated 02.03.2023, has sent a proposal for seniority fixation of Shri Yashpal Singh, IPS who was appointed to IPS by way of promotion from SPS quota on the basis of inclusion of his name in Select List of 2019.

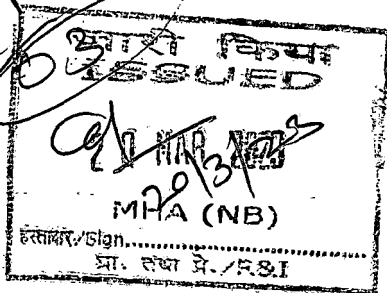


