// ORDER //

State Govt. of Chhattisgarh, vide letter no. F-01-22/2006/2-Home/IPS dated 11.10.2022, has sent a proposal for seniority fixation of 2 IPS officers who were appointed to IPS by way of promotion from SPS quota on the basis of inclusion of their names in Select List of 2016 & 2017.

2. The Seniority/year of allotment of officers has been computed as per Rule 3 (3)(ii) of the IPS Regulation of Seniority Rules, 1988 and as per amended seniority rules issued by DOP&T vide their notification dated 18.04.2012. Weightage formulas as per **amended seniority rules** are as under:-
