**ORDER**

- (ii) **Shri Mahesh Chand Bhardwaj and Ms. Geeta Rani Verma** shall be placed en-block below **Smt. Nupur Pasand (RR:2007)**, the junior-most direct-recruit IPS officer of 2007 batch of Jt. AGMU Cadre and above **Shri Anto Alphones (RR:2008)**, the senior-most direct-recruit IPS officer of 2008 batch of AGMU Cadre.
- (iii) **Shri Deepak Purohit** shall be placed below **Shri Devender Arya (RR:2008)**, the junior-most direct recruit IPS officer of AGMU Cadre and above **Shri Jasmeet Singh (RR:2009)**, the senior-most direct-recruit IPS officer of 2009 batch of AGMU Cadre.
