ORDER

Reference a proposal received from the UT division of this Ministry vide O.M. no 14016/20/2012-UTS-I dated 22.12.2015 forwarding service particulars of following (SPS) IPS officers of Arunachal Pradesh are appointed by the promotion to the Joint AGMUT cadre of Arunachal Pradesh Segment of Indian Police Service from the Select Lists of the years 2010 & 2012 for fixation of seniority/year of allotment

2. (ii) S/Shri **Kime Aya** shall be placed below **Ms Geeta Rani Verma (SPS: 2007)**, so far the junior most promotee IPS officer of 2007 batch, appointed from the Select List of 2012 to the UT segment of Joint AGMU Cadre of IPS and above **Shri Anto Alphones (RR: 2008)**, the senior most direct recruit IPS officer of 2008 batch of AGMUT Cadre of IPS.
