**ORDER**

With reference to State Government's letters no. 1/C1-1030/98HG/7300 dated 22.09.2011 and no. 1/C1-1030/1998HG4070 dated 15.05.2012, the seniority/year of allotment of 13 officers appointed from the year-wise Select Lists of the years 2007-A and 2008 to the Bihar Cadre of IPS **vide this Ministry's notification no I-14011/3/2010-IPS-I(II) dated 30.08.2011** has been computed under Rule 3 (3)(ii) of the IPS (Regulation of Seniority), Rules 1988 as amended from time to time and is shown in column no.7 of the table below:-

- (ii) **Shri Asghar Imam, Shri Sudhir Kumar, Shri Prakash Kumar Sinha, Shri Ajit Kumar Rai, Shri Md. Mansoor Ahmad, Shri Md. Rahman, Shri Mithu Prasad and Shri Sukan Paswan** shall be placed en-block below **Shri Shalin (RR:2001)**, the only direct recruit IPS officer of Bihar Cadre of 2001 batch and above **Shri Rakesh Rathi (RR:2002)**, the only direct recruit IPS officer of Bihar Cadre of 2002 batch;
- (iii) **Shri Barun Kumar Sinha, Shri Chandrika Prasad, Shri Binod Kumar No.2 and Shri Saurabh Kumar** shall be placed en-block below **Shri Rakesh Rathi (RR:2002)**, the only direct recruit IPS officer of Bihar Cadre of 2002 batch and above **Shri Rajesh Kumar (RR:2003)**, so far the senior most direct recruit IPS officer of Bihar Cadre of 2003 batch.
