**ORDER**

Sunil Kumar Naik (RR:2005)**, the junior-most direct recruit IPS officer of 2005 batch of Bihar Cadre and above **Miss Garima Malik (RR:2006)**, the senior most direct recruit IPS officer of 2006 batch of Bihar Cadre.
