The Government of Chhattisgarh's vide their No. F-01-01/2015/2- Home/IPS dated 18th May, 2016 has sent a proposal for fixation of seniority of IPS officers appointed on promotion from SPS quota on the basis of inclusion of their names in the Select List of the year 2014.
