ORDER

With reference to State Government's letter nos. Agrawal** shall be placed en-block below **Shri Rahul Sharma (RR:2002)**, the only direct recruit IPS officer of Chhattisgarh Cadre of 2002 batch and above **Shri Om Prakash Pal (RR:2003)**, so far the senior most direct recruit IPS officer of Chhattisgarh Cadre of 2003 batch.
