ORDER

- (iii) **Shri Sanjeev Shukla and Shri Hetram Manhar** shall be placed en-block below **Shri Shaikh Arif Husen (RR:2005)**, the junior-most direct-recruit IPS officer of 2005 batch and above **Shri Myinthungo Tungoe (RR:2006)**, the senior-most direct-recruit IPS officer of 2006 batch of Chhattisgarh Cadre.
