ORDER

Consequent upon the inclusion of the names of Shri Balbir Singh Thakur and Shri Bimal Gupta in the Select List of the year 2010 and their subsequent appointment to the Himachal Pradesh Cadre of IPS and with reference to State Government's letters no. Home D-B(15)-9/2013 dated 10.06.2014 and 20.06.2014, the seniority/year of allotment of all the officers appointed by promotion to the Himachal Pradesh Cadre of IPS from the year-wise Select Lists of the years 2006-A to 2010 **vide this Ministry's notifications no. I-14011/6/2011-IPS-I(II) dated 19.12.2011 and 05.06.2012 and no. only direct recruit IPS officer of 2003 batch of Himachal Pradesh Cadre;

- (iii) **Shri Jagat Ram and Shri Vinod Kumar Dhawan** shall be placed en-block below **Shri Pupul Dutta Prasad, IPS (RR:2003)**, the only direct recruit IPS officer of 2003 batch of Himachal Pradesh Cadre and above **Shri Agnihotri Sonal Mohan, IPS (RR:2004)**, the only direct recruit IPS officer of 2004 batch of Himachal Pradesh Cadre;
- (iv) **Shri Kapil Sharma** shall be placed below **Shri Agnihotri Sonal Mohan, IPS (RR:2004)**, the only direct recruit IPS officer of 2004 batch of Himachal Pradesh Cadre and above **Ms. Sumedha, IPS (RR:2005)**, the only direct recruit IPS officer of 2005 batch of Himachal Pradesh Cadre;
- (v) **Shri Rameshwar Singh Thakur, Shri Balbir Singh Thakur, Shri Prem Kumar Thakur, Shri Santosh Kumar Patial, Shri Sunil Kumar and Shri Chandra Shekhar** shall be placed en-block below **Shri Abhishek Dular, IPS (RR:2006)**, the junior-most direct recruit IPS officer of 2006 batch of Himachal Pradesh Cadre and above **Ms. Veena Bharti, IPS (RR:2007)**, the only direct recruit IPS officer of 2007 batch of Himachal Pradesh Cadre;
- (vi) **Shri Bimal Gupta, Shri Madhu Sudan and Ms. Rani Bindu** shall be placed en-block below **Ms. Veena Bharti, IPS (RR:2007)**, the only direct recruit IPS officer of 2007 batch of Himachal Pradesh Cadre and above **Shri S. Arul Kumar, IPS (RR:2008)**, the senior most direct recruit IPS officer of 2008 batch of Himachal Pradesh Cadre.
