**ORDER**

Reference a proposal received from the State Government vide letter No.Home-D-B(15)-9/2013 dated 07/01/2016 forwarding service particulars of following (SPS) IPS officers of Himachal Pradesh Cadre appointed by the promotion to the Himachal Pradesh cadre of Indian Police Service from the Select List of the year 2014 for fixation of seniority/year of allotment.
