**ORDER**

With reference to State Government's letter nos. (iii) **Shri Prabhat Singh** and **Shri Raghubir Singh** will be placed enblock below **Shri Vidhi Kumar Birdi (RR:2003)**, the juniormost RR:IPS officer of 2003 batch and above **Shri Atul Kumar Goyal (RR:2004)**, the seniormost RR:IPS officer of 2004 batch of Jammu & Kashmir Cadre.

(iv) **Shri Rattan Chand Mannotra**, **Shri Deepak Kumar Slathia** and **Amjad Parvez Mirza** will be placed enblock below **Shri Bhim Sen Tuti (RR:2004)**, the juniormost RR:IPS officer of 2004 batch and above **Shri Kaliraj Mahesh Kumar S (RR:2005)**, the only RR:IPS officer of 2005 batch of Jammu & Kashmir Cadre.

(v) **Rafeequl Hassan**, **Shri Virender Sharma** and **Shri Vijay Kumar** will be placed enblock below **Shri Kaliraj Mahesh Kumar S (RR:2005)**, the only RR:IPS officer of 2005 batch and above **Shri Amit Kumar (RR:2006)**, the only RR:IPS officer of 2006 batch of Jammu & Kashmir Cadre.
