ORDER

2. As per Rule 4 of the IPS (Regulation of Seniority) Rules, 1988, placement of aforesaid officer in the Civil List of Indian Police Service shall be as under:

- (ii) **Shri Nagendra Choudhary, Shri Amerjit Balihar, Shri Awadh Bihari Ram, Shri Prashant Kumar Karan, Shri Amarnath Mishra and Shri Vipul Shukla** shall be placed en-block below **Shri Akhilesh Kumar Jha (RR:2003)**, the only direct recruit IPS officer of 2003 batch and above **Shri Prabhat Kumar (RR:2004)**, so far the senior-most direct recruit IPS officer of Jharkhand Cadre of 2004 batch;
- (iii) **Shri Niranjana Prasad** shall be placed below **Shri Homkar Amol Vinukant (RR:2004)**, so far the junior-most direct recruit IPS officer of 2004 batch and above **Shri Kuldeep Dwivedi (RR:2005)**, so far the senior-most direct recruit IPS officer of Jharkhand Cadre of 2005 batch;
- (iv) **Shri Madan Mohan Lal, Shri Manoj Kumar Singh and Shri Chandra Shekhar Prasad** shall be placed en-block below **Shri Aseem Vikrant Minz (RR:2005)**, so far the junior-most direct recruit IPS officer of 2005 batch and above **Shri Anoop T. Mathew (RR:2006)**, so far the senior-most direct recruit IPS officer of Jharkhand Cadre of 2006 batch.
