ORDER

- (ii) **S/Shri Shashikant Shukla, Santosh Singh Gour, Mukesh Kumar Shrivastava, Sunil Kumar Pandey, Om Prakash Tripathy, Monika Shukla and Shri Manoj Kumar Singh** shall be placed en-block below **Shri Rudolf Alvares R. J. (RR:2009)** the junior-most direct recruit IPS officer of 2009 batch and above **Shri Abid Khan (RR:2010)**, the senior-most direct recruit IPS officer of 2010 batch of Madhya Pradesh Cadre of Indian Police Service.
