- (iv) **Shri A. R. Morale** shall be placed en-block below **Shri Trimukhe Abhishek Bhagwan (RR:2007)**, the junior-most direct recruit IPS officer of 2007 batch and above **Shri Paramjit (RR:2008)**, the senior-most direct recruit IPS officer of 2008 batch of Maharashtra Cadre;
- (v) **Shri R. S. Mane, Shri V. B. Deshmukh, Shri M. U. Patil, Shri S. B. Jadhav, Shri K. A. Kanse, Shri P. V. Ugale, Shri S. V. Pathak and Shri V. G. Patil** shall be placed en-block below **Shri Lalit Shakyawar (RR:2008)**, the junior-most direct recruit IPS officer of 2008 batch and above **Shri Navneet Bhasin (RR:2009)**, the senior-most direct recruit IPS officer of 2009 batch of Maharashtra Cadre.
