**ORDER**

2. As per Rule 4 of the IPS (Regulation of Seniority) Rules, 1988, the placement of the aforesaid officers in the Civil List of IPS will be as under:

Manaobi Singh (SPS:2003)**, so far the junior-most promotee IPS officer of 2003 batch of Manipur Cadre, appointed from the Select List of the year 2009 and above **Shri Themthing Nhashangva (RR:2004)**, the only direct recruit IPS officer of 2004 batch of Manipur Cadre.
- (ii) **Shri Th. Radheshyam Singh, Smt. Mamata Wahengbam, Shri Th. Basantakumar Singh, Smt. Achin Haokip and Shri Faumei Gonglin** shall be placed en-block below **Shri Kabib K. (RR:2005)**, the only direct recruit IPS officer of 2005 batch of Manipur Cadre and above **Smt. Pushpanjali Devi (RR:2006)**, the senior-most direct recruit IPS officer of 2006 batch of Manipur Cadre.
- (iii) **Shri Tonsing Kosing Anal, Md. Firoz Khan, Shri N. Manimohan Singh, Shri K. Chaoba Lokho Mao and Shri S. Amirlal Sharma** shall be placed en-block below **Shri Ningshen Worngam (RR:2007)**, the junior-most direct recruit IPS officer of 2007 batch of Manipur Cadre and above **Shri P. G. Singsit (RR:2009)**, the only direct recruit IPS officer of 2009 batch and there being no direct recruit IPS officer from 2008 batch of Manipur Cadre.
