ORDER

Reference to Government of Nagaland letter no. POL/ESTT/01/2014 dated 27.07.2015 forwarding therewith the particulars of Shri Meren Jamir, the lone promotee IPS officer appointed from the Select List of the year 2013 to the Nagaland Cadre of IPS.
