// ORDER //

The Government of Rajasthan's vide their letter No. F-6(3)pers/A-1/2015 dated 10th June, 2016 has sent a proposal for fixation of seniority of IPS officers appointed on promotion from SPS quota on the basis of inclusion of their names in the Select List of the year 2015. 
