ORDER

In continuation to this Ministry's order of even number dated 15.06.2012, the inter-se seniority of the officers appointed from the Select List of 2005 and 2007 to the Tripura Segment of Joint Manipur-Tripura cadre of IPS in the Civil List has been fixed in consultation with the Department of Personnel & Training and as per Rule 4 of the IPS (Regulation of Seniority) Rules, 1988, their placement in the Civil List of the Indian Police Service will be as under:

- (i) **Shri Smarajit Kanungoe and Shri Khatra Joy Reang** shall be placed en-block below **Smt. Vandana Karki (SPS:2000)**, so far the junior-most SPS officer of 2000 batch of Manipur Segment of Joint Manipur-Tripura Cadre (since her date of appointment to the Manipur segment of Joint Manipur-Tripura Cadre is before that of Shri Smarajit Kanungoe and Shri Khatra Joy Reang) and above **Shri Nishit Kumar Ujjwal (RR:2001)**, the senior-most direct recruit IPS officer of 2001 batch of Joint Manipur-Tripura Cadre;
- (ii) **Shri Uttam Kumar Majumdar and Shri Rajesh Sharma** shall be placed en-block below **Shri Lunsieh Kipgen (RR:2001)**, the junior-most direct recruit IPS officer of 2001 batch of Joint Manipur-Tripura Cadre and above **Shri Anish Prasad (RR:2003)**, the senior most direct recruit IPS officer of 2003 batch of Joint Manipur-Tripura Cadre;
- (iii) **Shri Gourab Chakraborty** shall be placed below **Shri H. Thanhaulien Gangte (RR:2003)**, the junior-most direct recruit IPS officer of 2003 batch of Joint Manipur-Tripura Cadre and above **Shri Themthing Nhashangva (RR:2004)**, the only direct recruit IPS officer of 2004 batch of Joint Manipur-Tripura Cadre.
