ORDER

With reference to State Government's letter No. F.2(1)-GA(P&T)/11 dated 12.07.2012, the seniority/year of allotment of all the 10 officers appointed by promotion to the Tripura segment of Joint Manipur-Tripura cadre of Indian Police Service from the year-wise Select Lists of the years 2009 and 2010 vide this Ministry's notification no. - (ii) **Shri Lalminga Darlong and Shri Soumitra Dhar** shall be placed en-block below **Smt. Princee Rani (RR:2005)**, so far the junior-most direct recruit IPS officer of 2005 batch and above **Smt. Pushpanjali Devi (RR:2006)**, the senior-most direct recruit IPS officer of 2006 batch of Jt. Manipur-Tripura Cadre;
- (iii) **Shri Arjun Debbarma, Shri Har Kumar Debbarma, Shri Jitendra Debbarma, Shri Carey Marak, Shri Bijoy Nag and Shri Suranjan Das** shall be placed en-block below **Shri Ningshen Worngam (RR:2007)**, so far the junior-most direct recruit IPS officer of 2007 batch of Joint Manipur-Tripura Cadre and above **Shri Saptarshi Abhijit Jaikrishna (RR:2008)**, the senior-most direct recruit IPS officer of 2008 batch of Joint Manipur-Tripura Cadre.
