ORDER

With reference to State Government's letter no. 405DG/SPS-2-13-538(1)/2012-I dated 18.04.2013, the seniority/year of allotment of 75 officers who were appointed to the Uttar Pradesh Cadre of Indian Police Service from the year-wise Review Select Lists of the years 2001 to 2009 **vide this Ministry's notification no. I-14011/10/2012-IPS.I(II) dated 21.12.2012 and no. I-14011/10/2012-IPS.I (I) & (II) dated 28.02.2013** has been computed as per Rule 3(3)(ii) of the IPS (Regulation of Seniority) Rules, 1988 as amended from time to time and is shown in column no.7 of the table below:-

*The year of allotment in respect of the officers at Sl. Nos. 11, 12, 20 to 24, 26 to 30, 34 to 48 and 60 have been restricted in pursuance to first proviso to Rule 3(3) (ii) of IPS (Regulation of Seniority) Rules, 1988.

2. As per Rule 4 of the IPS (Regulation of Seniority) Rules, 1988 placement of the names of the aforesaid officers in the Civil List of IPS will be as follows:

- (i) The officers from Sl. No. 1 to 9 shall be placed en-block below **Smt. Anupam Kulshreshtha (RR:1995)**, the junior-most direct recruit IPS officer of 1995 batch of Uttar Pradesh Cadre and above **Shri A. Satish Ganesh (RR:1996)**, the senior-most direct recruit IPS officer of 1996 batch of Uttar Pradesh Cadre.
- (ii) The officers from Sl. No. 10 to 13 shall be placed en-block below **Shri Amitabh Yash (RR:1996)**, the junior-most direct recruit IPS officer of 1996 batch of Uttar Pradesh Cadre and above **Shri Neelesh Kumar (RR:1997)**, the senior-most direct recruit IPS officer of 1997 batch of Uttar Pradesh Cadre.
- (iii) The officers from Sl. No. 14 to 18 shall be placed en-block below **Shri Deepak Ratan (RR:1997)**, the junior-most direct recruit IPS officer of 1997 batch of Uttar Pradesh Cadre and above **Shri Bhagwan Swaroop Srivastava (RR:1998)**, the senior-most direct recruit IPS officer of 1998 batch of Uttar Pradesh Cadre.
- (iv) The officers from Sl. No. 19 to 24 shall be placed en-block below **Shri Baduga Deva Paulson (RR:1998)**, the junior-most direct recruit IPS officer of 1998 batch of Uttar Pradesh Cadre and above **Shri Ramit Sharma (RR:1999)**, the only direct recruit IPS officer of 1999 batch of Uttar Pradesh Cadre.
- (v) The officers from Sl. No. 25 to 32 shall be placed en-block below **Shri Ramit Sharma (RR:1999)**, the only direct recruit IPS officer of 1999 batch of Uttar Pradesh Cadre and above **Shri Prashant Kumar II (RR:2000)**, the senior-most direct recruit IPS officer of 2000 batch of Uttar Pradesh Cadre.

- (vi) The officers from Sl. No. 33 to 58 shall be placed en-block below **Smt. Laxmi Singh (RR:2000)**, the junior-most direct recruit IPS officer of 2000 batch of Uttar Pradesh Cadre and above **Shri Tarun Gauba (RR:2001)**, the senior-most direct recruit IPS officer of 2001 batch of Uttar Pradesh Cadre.
- (vii) The officers from Sl. No. 59 to 75 shall be placed en-block below **Shri Praveen Kumar (RR:2001)**, the junior-most direct recruit IPS officer of 2001 batch of Uttar Pradesh Cadre and above **Smt. Sachi Ghildiyal (RR:2002)**, the senior-most direct recruit IPS officer of 2002 batch of Uttar Pradesh Cadre.

4. This letter supersedes all previous orders issued regarding fixation of seniority in respect of officers included in the Select Lists of the years 2001 to 2009 for promotion to Uttar Pradesh Cadre of Indian Police Service.

5. As regards the representations of the officers regarding non-restriction of their seniority on account of Amendment Seniority regulations, it is intimated that the amended regulation does not omit the said proviso from the cited rule and hence the request in the representations of the said officers is infructuous.

6. The concerned officers may kindly be informed accordingly.
