ORDER

With reference to State Government's letter no. 405DG/SPS-2-13-538(1)/2012-I dated 18.04.2013, the seniority/year of allotment of 60 officers who were appointed to the Uttar Pradesh Cadre of Indian Police Service from the year-wise Select Lists of the years 2009-A to 2011 **vide this Ministry's notification no. *The year of allotment in respect of the officers at Sl. Nos. 16 to 28, 30 to 49, 51 to 53 and 55 to 60 has been restricted in pursuance to first proviso to Rule 3(3) (ii) of IPS (Regulation of Seniority) Rules, 1988.

2. As per Rule 4 of the IPS (Regulation of Seniority) Rules, 1988 placement of the names of the aforesaid officers in the Civil List of IPS will be as follows:

- (i) The officers from Sl. No. 1 to 10 shall be placed en-block below **Smt. Aparna Kumar (RR:2002)**, the junior-most direct recruit IPS officer of 2002 batch of Uttar Pradesh Cadre and above **Shri Ajay Kumar Mishra (RR:2003)**, the senior-most direct recruit IPS officer of 2003 batch of Uttar Pradesh Cadre.
- (ii) The officers from Sl. No. 11 to 14 shall be placed en-block below **Shri Modak Rajesh Dineshrao (RR:2003)**, the junior-most direct recruit IPS officer of 2003 batch of Uttar Pradesh Cadre and above **Dr. Preetinder Singh (RR:2004)**, the senior-most direct recruit IPS officer of 2004 batch of Uttar Pradesh Cadre.
- (iii) The officers from Sl. No. 15 to 28 shall be placed en-block below **Shri Akhilesh Kumar (RR:2005)**, the junior-most direct recruit IPS officer of 2005 batch of Uttar Pradesh Cadre and above **Shri Dharmendra Singh (RR:2006)**, the senior-most direct recruit IPS officer of 2006 batch of Uttar Pradesh Cadre.
- (iv) The officers from Sl. No. 29 to 60 shall be placed en-block below **Shri Mohit Gupta (RR:2006)**, the junior-most direct recruit IPS officer of 2006 batch of Uttar Pradesh Cadre and above **Shri Amit Pathak (RR:2007)**, the senior-most direct recruit IPS officer of 2007 batch of Uttar Pradesh Cadre.

3. As regards the representations of the officers regarding non-restriction of their seniority on account of Amendment Seniority regulations, it is intimated that the amended regulation does not omit the said proviso from the cited rule and hence the request in the representations of the said officers is infructuous.

4. The concerned officers may kindly be informed accordingly.
