**ORDER**

- (ii) **Shri Atul Saxena** shall be placed below **Shri Nitin Tiwari (RR:2007)**, the junior-most direct recruit IPS officer of 2007 batch and above **Smt. Alankrita Singh (RR:2008)**, the senior-most direct recruit IPS officer of 2008 batch of Uttar Pradesh Cadre.
