**ORDER**

With reference to State Government's letter no. 625-P.S. Cell/HR/O/3P-05/12 dated 10.04.2013, the seniority/year of allotment of 8 officers who were appointed to the West Bengal Cadre of Indian Police Service from the Select List of 2011 **vide this Ministry's notification no. Cadre of IPS vide this Ministry's notification No. I-15011/20/2012-IPS.I dated 27.07.2012. And therefore, as per first proviso to Rule 3(3) (ii) of Seniority Regulations, the year of allotment of Smt. Jacqueline Dorjee has been restricted to 2007.

3. As per Rule 4 of the IPS (Regulation of Seniority) Rules, placement of the names of the aforesaid officers in the Civil List of IPS will be as follows:

- (i) **Smt. Jacqueline Dorjee** shall be placed below **Shri Arnab Ghosh (SPS:2007)**, so far the junior-most promotee IPS officer of 2007 batch of West Bengal Cadre and above **Shri Rasid Munir Khan (RR:2008)**, the senior most direct recruit IPS officer of 2008 batch of West Bengal Cadre;
- (ii) **Shri Amitava Barma, Shri Arindam Dutta Chowdhurey, Shri Kankar Prosad Barui, Shri Joy Biswas, Shri Shyam Singh, Shri Subrata Gangopadhyay and Shri Nilanjan Biswas** shall be placed en-block below **Shri Alok Rajoria (RR:2008)**, so far the junior most direct recruit IPS officer of 2008 batch of West Bengal Cadre and above **Smt. Debasmitta Das (RR:2009)**, the senior most direct recruit IPS officer of 2009 batch of West Bengal Cadre.
