
**// ORDER //**

Government of Himachal Pradesh, vide letter No. Home-D-B (15)-9/2013 dated 09-01-2020, has sent a proposal for fixation of seniority of IPS officers appointed on promotion from SPS quota of **Himachal Pradesh Cadre** on the basis of inclusion of their names in the Select List of the year 2016.

2. The seniority/year of allotment of the officers of Select List of the year 2016 has been computed under Rule 3 (3) (ii) of the IPS (Regulation of Seniority), Rules 1988, amended as per DOP&T vide notification No. 14014/4/2011-AIS-I(B) dated 18.04.2012 and other relevant rules. 
